# Walking and Talking with the Bushwalking Victoria President

## Board planning day

The Bushwalking Victoria board met for a planning day on 7 August 2016. Phillip Davis provided an insightful and thought provoking workshop about influencing decisions makers in government.

Other topics covered during the workshop included reviewing the current Bushwalking Victoria operational plan, discussing options for proceeding with the marketing project and clarifying our communications procedures and policies.

We made some good progress on these topics, but there is more work to do.

## Adventure Activity Standard

The other topic that has been consuming a lot of my time is discussions regarding the proposed Bushwalking National Adventure Activity Standard (NAAS) that is under the remit of Outdoors Victoria. The board endorses Bushwalking Australia's position on this – which is:

*'The proposed National Bushwalking AAAS must specifically exclude applicability to non-commercial users such as volunteer-run recreational groups including bushwalking clubs and groups of private individuals undertaking recreational adventure activities.'*

We are greatly concerned that that if the proposed Bushwalking NAAS is enacted in Victoria and elsewhere across Australia without an exemption for recreational bushwalkers, land managers and insurers will require compliance by recreational bushwalkers and their clubs, and that the vast majority of recreational bushwalkers and community groups would not be able to show compliance with the Bushwalking NAAS, which could prevent them from conducting their chosen recreational bushwalking activities.

We have conveyed our concerns to Outdoors Victoria, but so far have made no progress getting this exemption included. More details on this issue will be sent to all clubs and individual members in the near future.

## WalkSafe

We are making some progress updating *WalkSafe* to ensure it continues to be a useful resource for advising and guiding recreational bushwalkers.

## Bushwalking and Ski Touring Leadership Manual

We are also considering forming a small committee to update the *Bushwalking and Ski Touring Leadership Manual* and will soon call for expressions of interest for that.

## Club websites

If your club does not have a website and is considering getting one, Bushwalking Victoria funding to creating a website is still available.


Philip is married to Elizabeth, who participates in day walks and supported walks. They have two adult daughters. They live in Gippsland.



## Navigation Training Field Day: Practise Basic Navigation Skills

Bushwalking Victoria education trainers will conduct a navigation training field day so that new and potential club walk leaders can learn and practise basic navigation skills.


Participants will be provided via email with some pre-reading outlining some navigation techniques.

At the start of the day there will be a short theory and map reading skills session.

Participants will then set off in small groups to navigate a route in the park. The route will involve locating specific features at grid references, walking on a bearing, and timing and estimating distances.

Note the day does not cover advanced navigation.

## Forthcoming Vacancies on National Parks Advisory Council and Reference Areas Advisory Committee

I am writing to advise that the Minister for Energy, Environment and Climate Change is seeking expressions of interest for

- eight positions, including the Convener, on the National Parks Advisory Council; and
- six positions, including Chairperson, on the Reference Areas Advisory Committee.

### National Parks Advisory Council (NPAC)

NPAC is a statutory authority established under the National Parks Act 1975 to advise the responsible Minister on the administration of the Act and on proposed excision from a park referred to it by the Minister.

Applicants should have demonstrated experience and knowledge in one or more of the following areas:

- two people with skills or experience relating to the preservation and the protection of parks;
- one who is a professor or teacher of ecology, biology or earth science at a university in Victoria;
- one with experience in local government who resides in a municipality in which there is a park;
- four (at least two of whom reside outside of the metropolitan area) with experience in matters affecting the interests of the community.

Applicants are particularly encouraged to apply if they can demonstrate experience and expertise in nature conservation; recreation provision or tourism and ecology.

### Reference Areas Advisory Committee (RAAC)

RAAC is a statutory authority established under the Reference Areas Act 1978 to provide advice to the responsible Minister on the protection, control and management of reference areas.

Applicants should have demonstrated experience and knowledge in one or more of the following areas:

- three shall be nominated by the Minister; and
- three are appointed, who in the opinion of the Minister, have knowledge or expertise in one or more of the following areas: scientific disciplines concerned with matters relating to the preservation or management of land and ecological communities.

Applicants are particularly encouraged to apply if they can demonstrate experience and expertise in land management for conservation purposes; research promotion; strategic thinking and planning; risk management; and stakeholder management.

I encourage you to extend this notification to potential candidates within your professional networks.

## Change of Park Name to Recognise Traditional Owners?

Press release: 6 August 2016

Victorians are being asked to contribute to community consultation about a potential name change to both Mt Eccles National Park and the peak of Mt Eccles in the State's south west. The park forms part of the Budj Bim National Heritage Landscape area, which is currently being prepared for world heritage nomination, which will recognise its significant Aboriginal cultural values.

Parks Victoria's recent south west planning process showed strong community support for changing the name of the national park to Budj Bim National Park, and the Budj Bim Council recommended the peak be re-named Budj Bim.

Parks Victoria has a co-management agreement for the national park with the Gunditj Mirring Traditional Owners through the Budj Bim Council, which consists of Gunditj Mirring, Glenelg Hopkins Catchment Management Authority, the Department of Environment, Land, Water and Planning and Parks Victoria.

Parks Victoria will lead the community consultation, in partnership with the Gunditj Mirring Traditional Owners. People are invited to comments on the proposal to rename Mount Eccles to Budj Bim, and also to rename Mount Eccles National Park to Budj Bim National Park.

# Commercial Development in Victorian National Parks

Tourism Victoria is now named Visit Victoria. It merges Tourism Victoria's marketing division, the Victorian Major Events Company and the Melbourne Convention Bureau into a single umbrella organisation.

Visit Victoria's newly appointed CEO, Peter Bingeman, wants more hotels, restaurants and commercial nature-based activities to be built in some of the state's protected natural areas. The credo is for 'big nature' – private sector operators/commercial eco-tourism/commercial development - to be a core driver of visitation to regional Victoria and thereby increase spending by tourists.

Bradley Fauteux, CEO of Parks Victoria, as keynote speaker at the Bushwalking Victoria's Leadership Forum in July made the following points about the issue of commercial development in protected areas:

- Visitation is really important for long-term relevancy and to know what people think of protected places. 'If people don't love them, then they won't be protected'.
- Policy is driving economic outcomes for regions. The development of iconic walks is important here.
- 'Parks Victoria is not in the hospitality business'. Commercial development in parks needs to consider what types of facilities are appropriate.

Bushwalking Victoria has policies regarding [commercial activities](#) and [bushwalking infrastructure](#) in protected areas, as well as for the [conservation](#) of such areas.

The current Labor Government in Victoria has a more ambivalent attitude than the previous Coalition Government to large-scale developments in protected areas. If you want to provide feedback about Mr Bingeman's proposals, you should express them to your local member and the relevant minister. Bushwalking Victoria is also interested in receiving feedback from bushwalkers.


