## Bushwalking Victoria conservation and bushwalking amenity policies

Bushwalking Victoria's policies relating to conservation and bushwalking amenities have been reviewed, updated and published as four policy documents on the Bushwalking Victoria website:

- [Conservation](#) - covering conservation and related land management issues
- [Bushwalking Infrastructure](#) - covering tracks and trails, camping, huts, signage, information etc
- [Commercial Activities in Protected Areas](#) - covering commercial infrastructure, facilities and impacts in protected areas such as national parks, state parks and other reserves
- [Other Recreational User Groups](#) - covering our relationship with other significant users of protected areas.

## BTAC volunteer contributions

Over the past 12 months, BTAC volunteers have made a significant contribution to track maintenance and other activities.

In the 12 months to 30 June 2014, BTAC volunteers contributed a total of 884 hours of labour. In addition, individual clubs and Bushwalking Victoria members contributed at least a further 1000 hours of work. At Parks Victoria's standard rate for volunteer work, this represents over \$61 000 worth of effort.

Members from 13 clubs participated in BTAC events: Bayside, Border, Boroondara, Catholic, Diamond Valley, Essendon, Maroondah, Melbourne, Melbourne Women's Walking Club, Strzelecki, Victorian Mountain Tramping Club, Waverley, West Gippsland. In addition, at least one member from Melbourne University Mountaineering Club (an Associate club) participated.

### Ballarat and Central Victoria Field Officer

#### Mt Buninyong - South Track

A small team of Ballarat Bushwalking and Outdoor Club (BBOC) members joined forces with members of the Mt Buninyong Friends Group on Sunday 24 August to re-open the old walking trail around the south-eastern side of the mountain. The track starts between the Buninyong crater and Blackberry Lane, and winds around the east side of the mountain and up to the road and top of Mt Buninyong. The track had fallen into disrepair over the past decade and its re-opening allows a nice circular route from the car park below the crater to the summit and down the steep Summit Track, or along the road back to the crater. A large log and some work on the steps remain to be completed. Thanks to Peter Hiscock and all who took part in reccies, marking and trampling the route.

#### Grampians Peaks Trail (GPT)

There is strong interest from members of the Ballarat Bushwalking and Outdoor Club (BBOC), the Grampians Bushwalking Club and other individuals in Parks Victoria's **request that we** check the alignment for the southern section of the GPT. This section runs along little known the southern extension of the Mt William Range towards Mt Abrupt and Dunkeld. Gib Wettenhall of Great Dividing Trail Association (GDTA) is coordinating this project with Phil Brotchie (the BTAC Field Officer for Grampians) under direction of Parks Victoria. Dave Witham of Grampians Track Support group is also involved.

In addition, Bill Casey of the Essendon Bushwalking Club and other interested parties are organising a public walks on the central/souther section of the GPT over the weekend prior to the 2015 Melbourne Cup. We aim to walk the full GPT in 2016.

### Wilsons Prom

During August, Parks Victoria worked on clearing the Tongue Point track. The team will next work on the walking track from Martins Hill.

The Friends of the Prom is a voluntary incorporated organisation that provides assistance at Wilsons Prom such as raising and planting out indigenous flora and removing pest plants. They have a nursery at Tidal River where the plants are raised from seed collected on the Prom. They have done track work in the past and have quite a large number of local (Gippsland) members who may include some from walking clubs.

## Trashing the bush

Vandalism, illegal activities and rubbish dumping in the bush has long been a problem, which seems to be getting worse. Examples from the past year include:

- In March, Boroondara Bushwalking Club walked the Tanglefoot Track and encountered trail bike riders who gained access by going bush around gates and posts.
- In May, we had a report about people chopping down standing timber at Federation Hut over Easter to use for cooking in a hut stove.
- In June, John Petheram, BTAC Field Officer for Ballarat and Central Victoria, reported that the main issues on walks around Ballarat are the creation of unauthorised tracks and rubbish dumping. The increasing numbers of 4WD drivers and trail bike riders in the bush are increasing the incidence of track making and deepening. The uncontrolled use by 4WDs and trail bikes in the wet periods is a big worry. This is leading to serious loss of plant diversity and ground cover, greatly increased runoff and erosion into creeks and is contributing to floods in local towns and villages. Another impact is that previously pleasant walks are now deep rutted. On the Anglesea Heathland walk early this year, Boroondara Bushwalkers saw a spreading 3-4m tall tree completely and deliberately encased with thick mud from a large, deep wheel rut that must have deliberately widened and deepened for the purpose. The baked on mud on trunk, branches and foliage was severely stressing the tree.

- The August newsletter of Ben Cruachan Club reported that members met a dozen trail bike riders blazing a trail up the Avon River, blatantly riding past signs excluding bikes.

- In the past year, I have reported two gates pulled out of the ground with concrete footings still attached, have walked past at least five abandoned cars (one full of bullet holes), walked on tracks severely degraded by vehicles (they manage to get around exclusions humps) and took photos of two lots of illegal rubbish dumping. A ranger in one state park advised that 25% of their time/budget is spent cleaning up rubbish and repairing damage due to vandalism.

Walkers are not the only people concerned about illegal activity. In the October 2012 edition of *Trackwatch*, the President of Four Wheel Drive Victoria expressed his concerns about the growing reports of hoon behaviour and vandalism in the bush. Four Wheel Drive Victoria has a *Dob In a Hoon* form to report illegal behaviour. It can be downloaded from <http://www.fwdvictoria.org.au/default0.asp?First>

Illegal rubbish dumping is obviously a drain on local government too. *Warragul and Drouin Gazette* of 9 September, 2014 reported that Baw Baw Shire is conducting patrols around the municipality to crack-down on illegal rubbish dumping. The continuing need to clear illegally dumped waste creates significant costs for council. 'Offenders often dump rubbish in an area where they think they will not be seen.' Offenders face fines ranging from \$289 to more than \$1700 under the Environment Protection Act. If a matter proceeds to court, penalties can be up to \$5760. Bass Coast Shire is trying to establish who dumped rubbish. For now the rubbish is cordoned off with tape marked *Illegal Dumping Under Investigation*.

What can we do?

- Report illegal 4WD activities on the *Dob in a Hoon* form available at <http://www.fwdvictoria.org.au/default0.asp?First>.
- Use the *Snap Send Solve* app available for smart phones to photograph and report rubbish and vandalism. The app works out where you are, who manages incidents within that particular area and then sends through relevant information such as location, incident type and any related image to the appropriate authority. *Snap Send Solve* allows users to report incidents to every single council in Australia as well as a growing list of new organisations. # Activity Reports

## Wilsons Prom track clearing

12-14 September

Participants: Parks Victoria ranger Cathy; BTAC volunteers - Ailsa Mackenzie, Charles Ablitt, Fay and Dave Rimmer, Helen Frances, Ian McKellar, Joslin Guest, Lloyd Smiley, Mark Heath, Megan Major, Peter Conroy, and Sigrid Meier.

Because we were taking in heavy equipment – chain saws, brush cutters, hedge trimmers and their fuel and protective equipment – we had permission to take two vehicles in addition to ranger Cathy's Parks Victoria vehicle to the end of Telegraph Saddle Track. From there we carried the equipment the 4km to the light station, which was to be our base for the weekend.

Next morning we headed off early, met ranger Cathy and walked the more than 6km to our work area on the Waterloo-Lighthouse Track. The weather was ideal for working –cool (but slightly hazy) in the morning, warming to a sunny, but not hot, afternoon. We split into two groups to work on different parts of the track, each with a chainsaw, one brush cutter and one hedge trimmer for the intense cutting, plus hand saws, loppers and rakes for lighter trimming and clearing debris off the track. We worked until 4pm, having cleared several kilometres of track.

In addition to the sight of our beautifully clear track as we walked back and the enthusiastic compliments we received from bushwalkers, we had the special reward of seeing whales out towards Rondondo Island on Saturday evening and Sunday morning. Among them were a mother and her calf. We also saw seals cavorting.

Many thanks to ranger Cathy and the BTAC volunteers for their contribution to keeping the track open for others to enjoy, and to Renata and Colin for their hospitality at the light station.

## Buckertillible Cave Track (loop), Mt Buangor State Park
